**REORGANIZING THE MUNICIPAL DEVELOPMENT COUNCIL**

**WHEREAS**, under section 106 (a) of the Local Government Code, each local government unit shall have a comprehensive multi – sectoral development plan to be initialized by its development council and approved by its sanggunian;

**WHEREAS**, there is a need to reorganize the Local Development Council to aid in the economic and social growth and development of the Municipality of La Libertad;

**WHEREAS**, there is a call for the participation from the private sector and non – governmental organization in the planning process;

**NOW THEREFORE**, I, **ROMEO J. MEJIAS**, Local Chief Executive of the Municipality of La Libertad, Zamboanga del Norte, by virtue of the powers vested in me by law, do hereby issue this executive order, to wit;

**SECTION 1. Composition of Local Development Council.** The Local Development Council is composed of the following:

**SECTION 2. Functions of the Local Development Council.** The local Development Council shall exercise the following functions:

- 2.1 Formulate long – term, medium – term and annual socio – economic development plans and policies;
- 2.2. formulate the medium term and annual public investment programs;
- 2.3 Appraise and prioritize socio – economic development programs and projects;
- 2.4. Formulate local investment incentives to promote the inflow and direction of private investment capital;
- 2.5 Coordinate, monitor and evaluate the implementation of development programs and projects; and
- 2.6 Perform such other functions as may be provide by law or competent authority.

**SECTION 3. Meetings.** The Local Development Council shall meet once every six (6) months or as often as may be necessary.

**SECTION.4. Executive Committee.** The Local Development Council shall create an executive committee to represent it and act on its behalf when it is not in session.

4.2 Powers and Functions of the Executive Committee: The Executive Committee shall perform the following powers and functions:

- a. Ensure that the decisions of the council are faithfully carried out and implemented;
- b. Act on matters requiring immediate attention or action by the council;
- c. Formulate policies, plans and programs based on the general policies laid down by the councils; and
- d. Act on other matters that may be authorized by the council.

**SECTION 5. Sectoral or Functional Committees.** The Local Development Council may form sectoral or functional committees to assist them in the performance of their functions.

**SECTION 6. Secretariat.** A secretariat is constituted for the council which shall be responsible for providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required in the discharge of its functions.

The secretariat is composed of the following:

**SECTION 7. Relation of Local Development Councils to the Sanggunian are the Regional Development Council.**

7.1 The policies, programs and projects proposed by the local development council shall be submitted to the sanggunian concerned for appropriate action.

7.2 The approved development plans of the municipality shall be submitted to the Provincial Development Council which shall be integrated into the Regional Development Plan for submission to the National Economic and Development Authority (NEDA), in accordance with existing laws.

**SECTION 8. Effectively.** This Executive Order shall take effect immediately. So ordered
