**“AN ODER RECONSTITUTING THE MUNICIPAL ANTI – DRUG  
ABUSE COUNCIL (MADAC) OF THE MUNICIPALITY OF LA  
LIBERTAD, ZAMBOANGA DEL NORTE”**

**WHEREAS**, pursuant to Republic Act 7160, otherwise known as the Local Government Code of 1991, Section 16 specifically provides among others, that local governments shall improve public morals, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, social misdemeanors, criminalities and even vehicular and other incidents causing public disturbances are mostly rooted with drug abuse issues;

**WHEREAS**, for preventive measures and to help address on drug abuse and/or addiction, this municipality adopts and thereby conforms with the national government’s initiative to eliminate proliferation and use of illegal drugs and promote peaceful, orderly and harmonious atmosphere in the Municipality of La Libertad, Zamboanga del Norte;

**NOW THEREFORE I, ROMEO J. MEJIAS**, Municipal Mayor of La Libertad, Zamboanga del Norte, by virtue of the powers vested in me by law, do hereby order that the Municipal Anti – Drug Abuse Council (MADAC) be organized:

**SECTION I. COMPOSITION.** The Municipal Anti – Drug Abuse Council shall be composed of the following:

**SECTION II. FUNCTIONS.** The MADAC shall perform the following:

1. Serve as the focal point through which various organization and individuals work together cooperatively in planning, implementation and evaluation of programs on drug abuse prevention.
2. Provide effective mechanisms for the coordination of existing services and programs and those which might be developed in the immediate future.
3. Provide mechanism to obtain funds, volunteers, facilities and technical expertise.
4. Perform other related responsibilities as may be assigned by component authorities.

**SECTION III. MEETINGS.** The MADAC shall convene within thirty (30) days from the effectivity of this Order and shall meet quarterly thereafter.

**SECTION IV. EFFECTIVITY.** The Order shall take effect immediately.
