**"REORGANIZING THE MUNICIPAL PEACE AND ORDER COUNCIL
(MPOC) DEFINING ITS ORGANIZATION, DUTIES AND FUNCTIONS
AND OTHER RELATED ACTIVITIES"**

WHEREAS, Section 116 in the Local Government Code of 1991, otherwise known as Republic Act 9160 (RA 9160) provides that there is hereby established in every province, city and municipality a local peace and order council, pursuant to Executive Order No.309, as amended, Series 1998;

WHEREAS, in furtherance of the performance of the council and in the framework of discharging mandated functions and duties relative to maintenance of peace and order in the local jurisdiction;

NOW THEREFORE, I ROMEO J. MEJIAS, Municipal Mayor of La Libertad by virtue of the powers vested in me by law, do hereby cause the reorganization of the Municipal Peace and Order Council.

Section I. REORGANIZATION OF THE MUNICIPAL PEACE AND ORDER COUNCIL (MPOC) – There is hereby reorganized a Municipal Peace and Order Council to be composed of the following:

Section II – DUTIES AND FUNCTIONS OF THE MUNICIPAL PEACE AND ORDER COUNCIL. There shall handle the administrative and technical works of the Municipal Peace and Order, the following are its function and responsibilities:

1. Convene the POC quarterly or as often as need arises;
2. Provide a forum for inter – disciplinary dialogue and deliberation of major issues and concerns affecting peace, order and public safety nationwide;
3. Recommend strategic actions or activities aimed at promoting, improving or enhancing measures, within their respective jurisdictions;
4. Formulate and adopt an effective mechanism for the coordination, cooperation and consultation involving the local executives, citizenry and law enforcement agencies under Republic Act No. 6975, as amended, in the adoption of the Community and Service – Oriented Policing (CSOP) System;
5. Provide staff and financial support to the POC Secretariat;

Section III – MUNICIPAL PEACE AND ORDER COUNCIL SECRETARIAT (MPOCs). There shall be a Municipal Peace and Order Council Secretariat which handle the administrative and technical works of the Municipal Peace and Order Council.
