AND MANAGEMENT COUNCIL (MDRRMC) OF LA LIBERTAD,

Section 2. Duties and Functions:

1. Approve, Monitor and Evaluate the implementation of the LDRRMOs and regularly review and test the plan consistent with other national and local planning programs;
2. Ensure the integration of disaster risk implementation and climate change adaptation into local development plans, programs and budgets as a strategy.
3. Recommend the implantation of forced or preemptive evacuation of local residents, if necessary; and
4. Convene the local council once every three (3) months or as necessary.

Section 3. Effectivity:

This Executive Order shall take effect immediately.
