"AN ORDER CREATING THE MUNICIPAL ROAD CLEARING TASK FORCE AND GRIEVANCE COMMITTEE OF THE MUNICIPALITY OF LA LIBERTAD, ZAMBOANGA DEL NORTE."

WHEREAS, pursuant to the DILG Memorandum Circular No. 2020-027 dated 07 February 2020 with the subject "CONTINUED IMPLEMENTATION OF THE PRESIDENTIAL DIRECTIVE TO CLEAR ROADS OF ILLEGAL OBSTRUCTIONS (ROAD CLEARING 2.0);

WHEREAS, the Municipal Government of La Libertad, Zamboanga del Norte has paved its way to the re-constitution of the Road Clearing Task Force which is directed to perform the said issuance within its area of jurisdiction;

WHEREAS, the Municipal Government of La Libertad, through the Road Clearing Task Force, shall exercise the reclaim of public roads and canals which are being used for private ends and in the process, rid them of illegal structures and constructions;

WHEREAS, the said task force shall ensure immediate and effective implementation of road clearing operations and encourage strategic planning to avoid exacerbating problems on obstructions in all public roads of La Libertad;

NOW, THEREFORE, I, ROMEO J. MEJIAS Municipal Mayor, Municipality of La Libertad, Zamboanga del Norte, by virtue of the powers vested in me by law do hereby order the following:

SECTION 1. CREATION. There shall be created Road Clearing Task Force in the Municipality of La Libertad, Zamboanga del Norte.

SECTION 1.1. COMPOSITION. The following shall compose the Road Clearing Task Force of the Municipality of La Libertad, Zamboanga del Norte to wit:

SECTION 1.2. RESPONSIBILITY. The Road Clearing Task Force shall perform the following:

Conduct meetings as often as necessary;

 Recommend to the Sanggunian the enactment of ordinances related to road clearing and banning of illegal construction;



- 3. Prepare an inventory of roads within the Municipality;
- 4. Develop and implement displacement strategies;
- 5. Cause the rehabilitation of recovered public roads;
- 6. Conduct consultative meetings and/or dialogues with the community such as business sectors, homeowners association, tricycle operators and drivers association (TODA), among other existing groups/organizationson the rules and policies covering technical requirements in constructing or renovating buildings and structures to secure the life, health, property and welfare of the people; and
- 7. Perform other related responsibilities as may be assigned by competent authorities.

SECTION 2. GRIEVANCE COMMITTEE. There shall be formed a Grievance Committee to be composed of the following:

SECTION 2.1 RESPONSIBILITY. The Grievance Committee shall:

- 1. Consider and process grievances arising from the conduct of road clearing operations;
- 2. Verify and act on reports of unremoved obstructions;
- 3. Establish feed-backing mechanisms to capture suggestions from the community that could lead the task force to a better implementation of road clearing programs.

SECTION 3. EFFECTIVITY. This order shall take effect immediately upon its issuance.
