EXECUTIVE ORDER NO. 20-04- 010 Series of 2020

AN EXECUTIVE ORDER AMENDING THE CURFEW HOURS AND IMPOSING LIQUOR BAN IN THE IMPLEMENTATION OF COMMUNITY QUARANTINE IN THE MUNICIPALITY OF LA LIBERTAD

WHEREAS, a meeting of the local chief executives of the various cities and municipalities in the province of Zamboanga del Norte was conducted at Provincial Capitol on March 31, 2020;

WHEREAS, one of the agenda discussed during the meeting was the prevalence of confirmed COVID-19 cases in the neighboring provinces of Zamboanga del Norte;

WHEREAS, it was further observed that there has been confirmed COVID-19 cases from Negros Oriental, Cebu City, Misamis Oriental, Misamis Occidental, Zamboanga del Sur, Lanao del Norte and Zamboanga City;

WHEREAS, the Provincial Governor of Zamboanga del Norte, Roberto Y. Uy has recently issued Executive order No. 20-31, Providing a harmonize guidelines to strengthen the implementation of the community quarantine in the Province of Zamboanga del Norte which shall be known as "UNIFIED ZAMBOANGA DEL NORTE";

WHEREAS, there is a need of the Local Government to impose only a community quarantine in the respective territorial jurisdictions;

NOW, THEREFORE, I, ROMEO J. MEJIAS, Municipal Mayor of La Libertad, by virtue of the powers vested in me by the Local Government Code and such other laws, and in order to prevent the transmission of Corona Virus Disease 2019 (COVID-19), do hereby order;

SECTION 1: MUNICIPAL CURFEW HOURS

There shall be a municipal curfew hours to be adopted by all barangays in the municipality, curfew hours shall be:

For minors (below 18 years of age)
 For Adults
 from 6:00pm to 6:00am
 from 10:00pm to 4:00am

The PNP shall conduct regular monitoring during the curfew hours and ensure increased police visibility in the communities in order to ensure that no individual violates the curfew hours, except frontliners.

SECTION 2: MUNICIPAL LIQUOR BAN

The sale, distribution and consumption of beer, rhum, brandy, whisky, vodka, and other forms of liquor in any public place shall be prohibited during the period of community quarantine.

SECTION 3: WORK IN THE GOVERNMENT

The LGU-La Libertad may adopt a skeletal work force scheme. However, the following workers in the government are excluded therefrom:

- 1. PNP, BFP and other uniformed personnel;
- 2. Personnel involved in health work, border control, emergency, and other mission critical services;
- 3. Other frontline personnel.

No travels, seminars, trainings, and other similar events shall be allowed. The conduct of flag ceremonies and the use of biometrics shall be deferred.

SECTION 4: EFFECTIVITY CLAUSE

This executive order shall be effective on April 8, 2020 at 12:01am until April 30, 2020 unless sooner revoked or extended should conditions warrant.
