**AN ORDER CONSTITUTING THE MONITORING TEAM FOR THE
IMPLEMENTATION OF DILG-DBM-DSWD-DOLE-DTI-DOF-DA JMC NO. 1, SERIES
OF 2020 OF THE MUNICIPALITY OF LA LIBERTAD, ZAMBOANGA DEL NORTE**

WHEREAS, Proclamation No. 922 s, 2020, was issued declaring a State of Public Emergency throughout the Philippines due to Corona Virus Disease 19 (Covid-19), enjoining all government agencies and local government units (LGUs) to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the threat of Covid-19;

WHEREAS, with the passage of Republic Act No. 11469, otherwise known as the “Bayanihan to Heal as One Act of 2020”, an intensified government response is adopted whereby the national government will render full assistance to the LGUs and mobilize the necessary resources to undertake urgent and appropriate measures to curtail the effects of the recent declarations on the economic, physical and psychosocial well-being of the most affected residents;

WHEREAS, the Joint Memorandum Circular (JMC) No. 1, s. 2020 by the DILG, DBM, DOLE, DSWD, DTI, DA, DOF, outlined the guidelines for the provision of social amelioration programs (SAP) to the most affected residents of the areas of the enhanced community quarantine due to Covid-19 pandemic;

WHEREAS, to carry out the Social Amelioration Program (SAP), the Department of Social Welfare and Development issued Memorandum Circular No. 4, s. 2020, or the Special Guidelines on the Provision of Social Amelioration Measures by the Department of Social Welfare and Development to the Most Affected Residents of Areas Under Enhance Community Quarantine and Continuation of the Implementation of the Social Pension for Indigent Senior Citizens and Supplementary Feeding Programs where the Barangay shall identify and prepare the list of qualified beneficiaries based on the eligibility requirements provided in the guidelines;

NOW, THEREFORE, I, **ROMEO J. MEJIAS**, Municipal Mayor of La Libertad, Zamboanga del Norte, by the virtue of the powers vested in me by law, do hereby order the following:


Section 1. **ORGANIZATION AND COMPOSITION OF THE MONITORING TEAM.** There is hereby organized a MONITORING TEAM FOR THE IMPLEMENTATION OF DILG-DBM-DSWD-DOLE-DTI-DOF-DA JMC NO. 1, SERIES OF 2020 which shall be composed of the following:
