AN EXECUTIVE ORDER REORGANIZING THE MEMBERS OF THE BIDS AND AWARDS COMMITTEE (BAC), THIS MUNICIPALITY FOR THE CALENDER YEAR (CY) 2020.

WHEREAS, with the end view of promoting ideals of good governance in the procurement process of infrastructure projects, goods and consulting services regardless of source of funds and in the implementation of procurement contracts, congress enacted Republic Act 9184, an act providing for the modernization standardization and regulation of the procurement activities of the government and for other purposes on January 6, 2020 executive order no. 20-10-001A, was issued establishing the Bids and Awards Committee (BAC) this municipality, and designating the members of the same this Local Government Unit.
