**EXECUTIVE ORDER NO. 20-05-013**  
*Series of 2020*

**AN ORDER ORGANIZING THE CONTACT TRACING TEAM (CTT) OF  
LA LIBERTAD, ZAMBOANGA DEL NORTE.**

**WHEREAS**, Article II, Section 15 of the Constitution, which declares that the State shall protect and promote the right health of the people and instill health consciousness among them;

**WHEREAS**, Republic Act No. 11496, or the “Bayanihan to Heal as One Act”, has placed the country in a State of national Emergency, and has declared the urgent need to: (a) mitigate, if not contain, the transmission of COVID-19; (b) undertake measures that will prevent the overburdening of the healthcare system; (c) immediately and amply provide healthcare, including medical tests and treatments, to COVID-19 patients, persons under investigation (PUIs), or persons under monitoring (PUMs); ensure that there is sufficient, adequate and readily available funding to undertake the foregoing; (e) partner with the private sector and other stakeholders to deliver these measures and programs quickly and efficiently; and (h) promote and protect the collective interest of all Filipinos in these challenging times;

**WHEREAS**, DILG issued Memorandum Circular No. 2020-062 dated March 21, 2020 providing for the suppletory guidelines for LGUs in the implementation of the enhanced community quarantine in the Philippines;

**WHEREAS**, DOH issued Department Memorandum No. 2020-0151 dated March 30, 2020 regarding the Interim Guidelines on Expanded Testing for COVID-19;

**WHEREAS**, DILG issued Memorandum Circular No. 2020-073 dated April 13, 2020 providing for the guidelines for the conduct of the expanded testing procedures for COVID-19 and directing LGUs to formulate the Contact Tracing team;

**NOW, THEREFORE, I, ROMEO J. MEJIAS**, Municipal Mayor, by virtue of the powers vested in me by Law, do, hereby organize the Contact Tracing Team:

Section 1. **Composition.** The CCT shall be composed of the following, to wit:

Section 2. **Functions.** The CCT shall perform the following:

- 1) Conduct contact tracing those with known exposure to a COVID-19 patient to ensure that they are strictly observing the home-quarantine measures;
- 2) Monitoring the status of Person Under Investigation (PUI), Person Under Monitoring (PUM), family members with known contact to a confirmed case to mitigate possibility of contagion;
- 3) Report daily update to the COVID-19 Provincial and Regional Task Force.

Section 3. **Effectivity.** This Executive Order shall take effect immediately.
