CREATION OF MUNICIPAL STEERING COMMITTEE FOR KALAHI-CIDSS: AF DROP IMPLEMENTATION IN THE MUNICIPALITY OF LA LIBERTAD, ZAMBOANGA DEL NORTE

WHEREAS, the Municipality of La Libertad is now a recipient of Kapit Bisig Laban sa Kahirapan- Comprehensive and Integrated Delivery of Social Service: Additional Funding Disaster Response Operation Procedure (KALAHI-CIDSS: AF DROP)

Section 2. MUNICIPAL STEERING COMMITTEE/ROLES AND RESPONSIBILITIES

- a. Facilitate creation of an operating environment conducive to the implementation of the project,
- b. Ensure adequate policies are in place to support pilot activities and processes;
- c. Guarantee availability of local financial and human resources to support operational requirements, and
- d. Ensure that implementation activities are properly implemented, monitored, and periodically assessed and evaluated, and experiences documented to ensure capture of lessons, insights and best practices.

Section 3. This Executive Order shall take effect immediately and shall remain in force as agreed in the Memorandum of Agreement signed by both parties.
