**CREATING THE LOCAL VERIFICATION COMMITTEE (LVC) FOR THE
NATIONAL HOUSEHOLD TARGETING SYSTEM FOR POVERTY REDUCTION
OR LISTAHANAN IN THE MUNICIPALITY OF LA LIBERTAD, ZAMBOANGA
DEL NORTE**

WHEREAS, Executive Order, No. 867 Series of 2010 issued on March 9, 2010 Providing the Adoption of the National Household Targeting System for Poverty Reduction as the Mechanism for identifying Poor Households who shall be recipients of Social Protection Programs Nationwide;

WHEREAS, Listahanan, formerly known as the National Household Targeting System for Poverty Reduction (NHTS-PR), aims to establish a socio-economic database of poor and non-poor households as reference in identifying potential recipients of social protection programs and services;

WHEREAS, the Department of Social Welfare and Development (DSWD) as coordinator with the implementation of the LISTAHANAN in the Local Government Units concerned;

WHEREAS, to attain the objective, there is a need to organize a Local Verification Committee (LVC) to address various concerns regarding the LISTAHANAN, particularly in its validation and finalization phase;

NOW, THEREFORE, I, ROMEO J. MEJIAS, Municipal Mayor of La Libertad, by virtue of the powers vested in me by law, do hereby order:

Section 1. COMPOSITION. The LVC shall be composed of the following:

Section 2. FUNCTIONS. The LVC shall have the following functions:



- 2.1 Resolve all grievances and appeals brought by individuals or groups;
- 2.2 Identify households that have not been assessed; and
- 2.3 Certify the completeness and incompleteness of the list of households living below the poverty threshold along with the recommended changes.

Section 3. REPEALING CLAUSE. All orders, local issuances, or rules inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

Section 4. EFFECTIVITY CLAUSE. This Order shall take effect immediately.
