**AN EXECUTIVE ORDER REORGANIZING THE MEMBERS OF THE BIDS AND AWARDS COMMITTEE (BAC), THIS MUNICIPALITY FOR THE CALENDAR YEAR (CY) 2021**

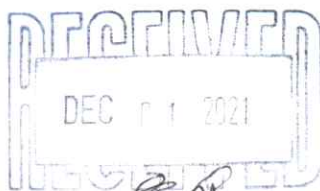
