AUTHORIZING THE HONORABLE MAYOR ROMEO J. MEJIAS, THIS MUNICIPALITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THIS LOCAL GOVERNMENT UNIT AND THE JOSE RIZAL MEMORIAL STATE UNIVERSITY FOR THE INSTALLATION OF DROP BOXES IN THE MUNICIPALITY AS AN AID IN THE FULL IMPLEMENTATION OF THE FLEXIBLE LEARNING SYSTEM AMIDST THE COVID-19 PANDEMIC, AND TO SIGN PERTINENT DOCUMENTS RELATIVE THERETO

WHEREAS, the Jose Rizal Memorial State University (JRMSU) - Main Campus is an institution adopting the measures set by the Commission on Higher Education (CHED) in the conduct of Flexible Learning System for the First Semester of Academic Year 2020-2021;

WHEREAS, JRMSU - Main Campus is partnering with the different municipalities inside and/or outside the province of Zamboanga del Norte for the installation of drop boxes which shall be used for the submission of the students' outputs amidst the CoViD-19 pandemic;

WHEREAS, this municipality, being identified as the closest location to most of the residences of the students currently enrolled in the JRMSU - Main Campus, shall install a drop box and provide the site or location for which the drop box shall be installed to assist the students in our locality;

WHEREAS, this municipality pledge to comply and work out on the set duties and responsibilities stipulated therein on the installation of a drop box in our locality;

WHEREFORE, on motion of Honorable Floripinas T. Saren, duly seconded by Honorable Elmer C. Hangcan and Honorable Felmer B. Ligutom, it was

RESOLVED, as it is hereby resolved, to authorize the Honorable Mayor Romeo J. Mejias, to enter into a MOA by and between this Local Government Unit and the JRMSU - Main Campus for the installation of drop boxes as an aid in the full implementation of the Flexible Learning System amidst the CoViD-19 pandemic, and to sign pertinent documents relative thereto.
